- Note: There is no provision for an evening meal on Friday 10th October 2014, participants will be required to make their own arrangements

1. Registration Form.

The Registration Fee includes all plenary sessions, lunches, tea breaks, and dinners for 4 nights.

- Section 1A Page 1 completed by members attending full time. One for each full time attendee. Note all conference meals and the cruise are included in the cost of \$650.00.
- Section 1B Page 2 completed by members who will only be joining us for the 4 meals (see the bottom of the page) and *does not authorise* attendance at any other portion of the World Conference.
- Section 2 Conference Accommodation Page 3. To be completed for full time attendee/partner also attending full time/accompanying persons
- Section 3 Optional Extras. Page 4 - to be completed by those who wish to attend any of the optional excursions.
- Section 6: Summary of Booking Page 5. To show all the fees for full time and if appropriate the accompanying persons. This includes accommodation Page 3; Conference fee \$650.00 per person (full time attendees 1A); Meals for accompanying person Page 2); Optional excursions Section 3; airport transfers Section 4; Post Conference Tours Section 5.
- Section 10: Emergency Contact Details and Insurance – Signature and date of application
- Section 11: Travel Details if known at the time of completing application.

Section 1: Conference Volunteer

Volunteers will generally be assigned to a 3-4 hour shift at the Conference venue at Sydney Showground, Sydney Olympic Park; at Kingsford Smith Airport; at Hotels or at transport load/unload points. Volunteers may sit in on the Conference before or after their shift in designated areas behind Delegates and Observers.

Volunteers will be issued with a Volunteer Name Tag. There will be a short compulsory training for all volunteers appropriate to your role, either at the airport or at Sydney Showground, Sydney Olympic Park. Street parking is available for \$20 per day if booked online. No meals supplied.
